



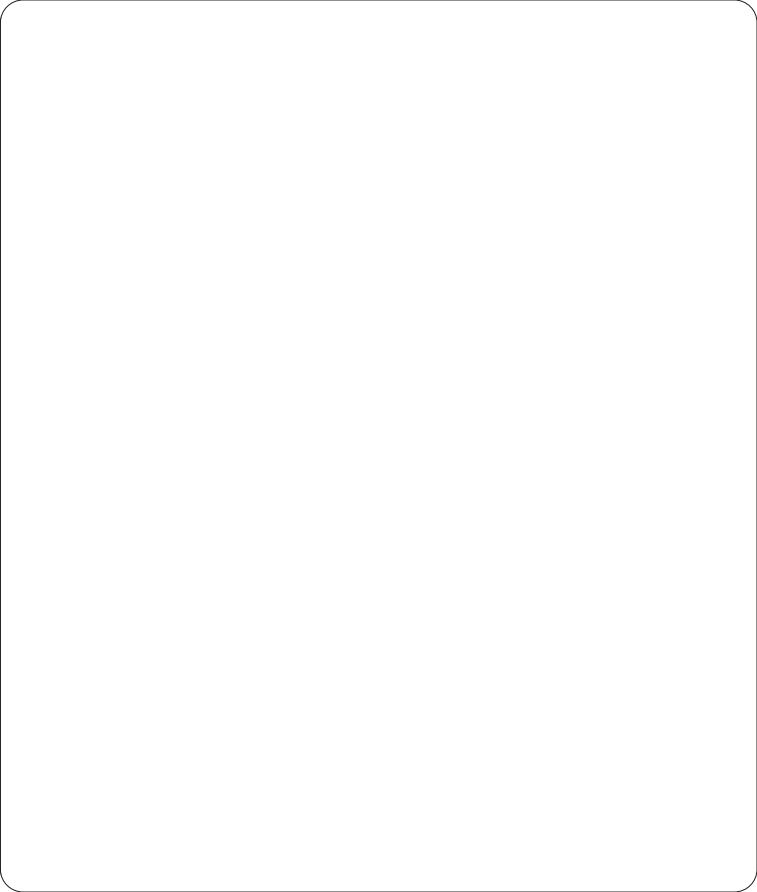

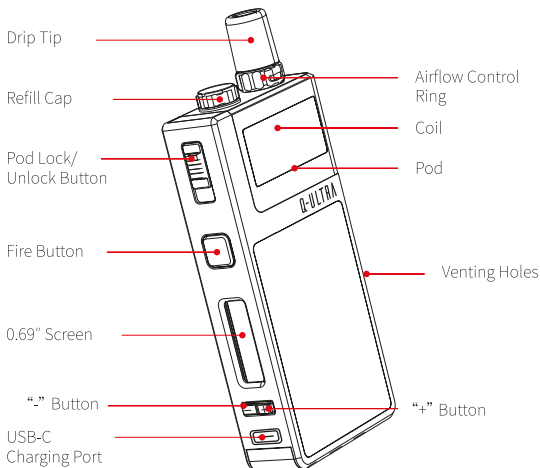

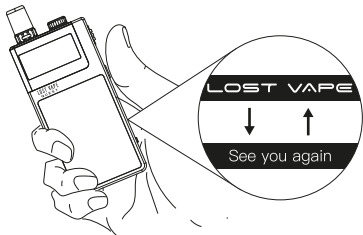

3 BASIC OPERATION OF DEVICE



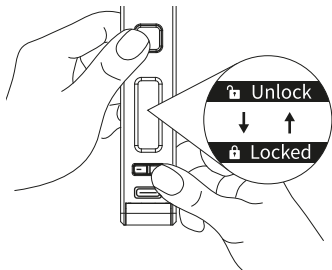
● Power On/Off

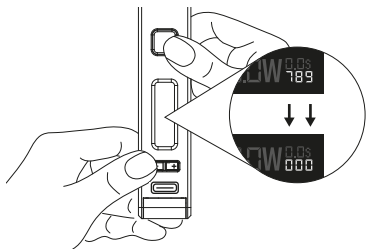
Consistently press the Fire button 5 times to turn on/off the device. The screen displays “Lost Vape” once you turn it on, and “See You Again” appears on the screen as you turn it off.

● Wattage lock/unlock

Hold the Fire button and “+” button together to lock/unlock the wattage settings. The screen will display “Locked/Unlock”.

Beware: The Fire button will still work while the wattage setting is locked!



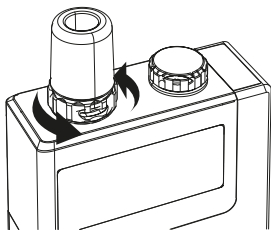


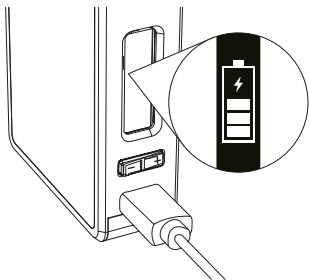
● **Reset Puff Counter**

Hold the Fire button and "-" button together to set the puffs to Zero.

● **Airflow Adjustment**

Twist the airflow control ring to adjust the airflow according to your taste.





● Charging

Connect the USB-C cable to a power source. The battery icon will begin to animate and stop animating once fully charged.

ATTENTION: Pass-through is not allowed.

① Battery Level



② Coil Resistance



③ Wattage Value



④ Last Vaping Time: The data will be cleared after pressing the Fire Button, and your vaping time will be recalculated.



⑤ Puffs Count (From 000 to 999)

5 SECURITY PROTECTION

Too Hot

●Overheat protection (Once the device temperature beyond 75°C, it will stop working automatically and the screen shows “Too Hot”)

Low Battery

●Low voltage protection (Once the battery voltage below 3.2V, the device will stop working automatically and the screen shows “Low Battery”)

Check Atomizer

●Short circuit protection (Once the device cannot check the pod, the screen shows” Check Atomizer”; Once the resistant of the coil beyond 0.1ohm, when you press the fire button, the screen shows “Short circuit”)

Over 10s

●10 seconds over-time protection (Once you vape over 10s at one time, the device will stop working automatically and the screen shows “Over 10s”)



●Overcharge protection (Once fully charged, the device will stop charging and the screen shows “fully charged icon”).

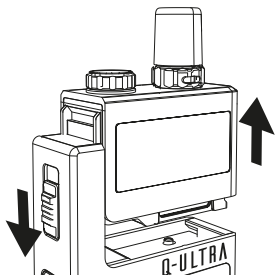

7 HOW TO FILL THE E-LIQUID

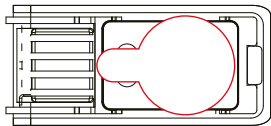


● STEP 1

Slide down the pod lock/unlock button to release the pod, then pull it off the device.

● STEP 2

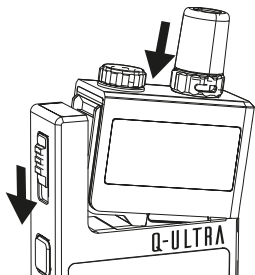
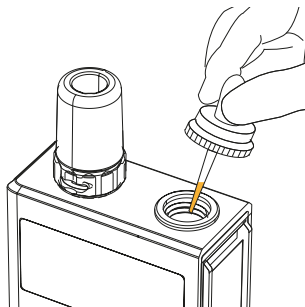
Remove the protective tape at the first time.



● **STEP 3**

Unscrew to open the refill cap, then fill the e-liquid into the pod. Screw the refill cap once the filling is completed.

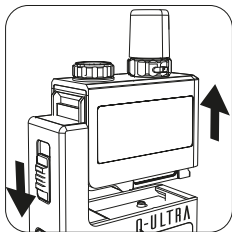
ATTENTION: To avoid dry hit, please refill the pod immediately when the level of e-liquid drop to the e-liquid hole. After filling e-liquid into a pod with the new coil, please let the pod stand for 15 minutes to avoid the possibility of coil-burning.



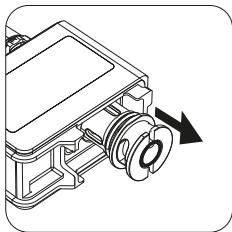
● **STEP 4**

Slide down the pod lock/unlock button, and put the pod in the right place. Then release the button to lock it.

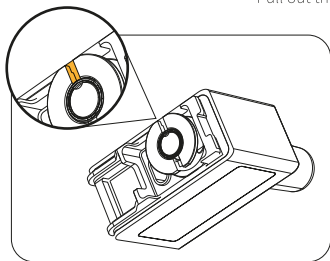
8 HOW TO REPLACE THE COIL



- **STEP 1**
Release the pod.



- **STEP 2**
Pull out the old coil directly.



- **STEP 3**
Make the slot be facing on the side of the pod, then align the new coil and insert it into the pod.

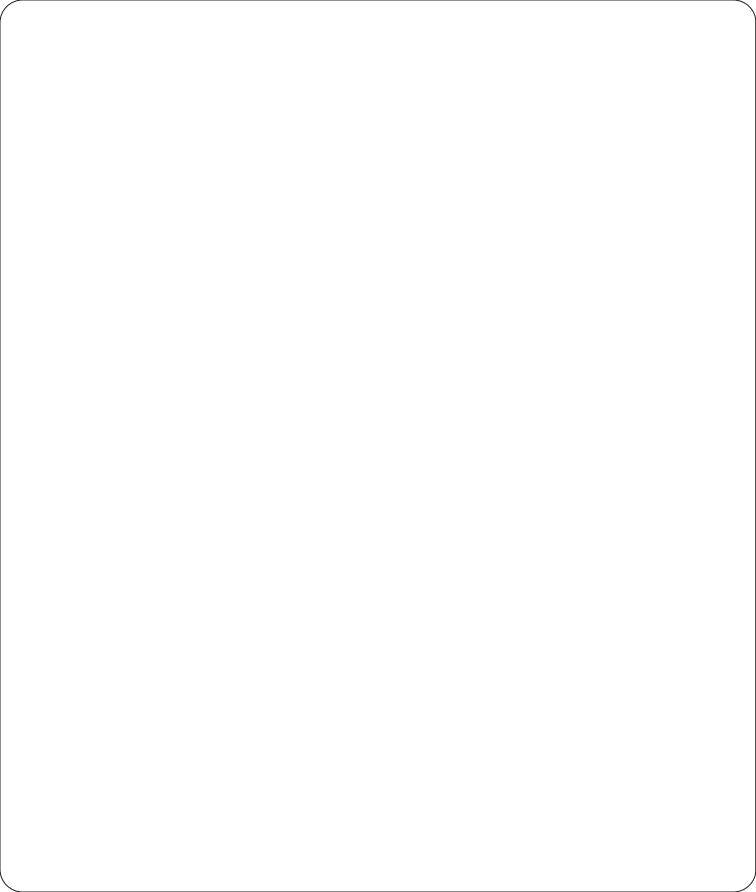
